### Policy Update

#### Children's Cabinet Update

Governor Rauner's Cabinet on Children and Youth met this past Thursday, March 9th. The Cabinet discussed updates on its three current projects:

- Reducing Childhood Lead Burden: Illinois Math and Science Academy recently held a Hack-a-Thon to brainstorm potential strategies to address this problem.
- Apprenticeships: A panel discussed the importance of apprenticeships and a lively discussion followed that detailed the importance of diversity in STEM and workforce preparedness for middle and high school students. Governor Rauner emphasized that all Illinois high schools should offer not only a diploma but the opportunity for all youth to graduate with a credential.
- Early Childhood Workforce Development: The group discussed the inadequate number of educated and qualified early childhood educators and lack of clear pathways for current workforce to increase career opportunities.

### **Social Services Contract Notice**

The Social Services Contract Notice Act, [HB3110](#), is on its second reading in the House. This bill was written in response to the Good Friday social services cut that took place in April 2015. The bill would require the state of Illinois to provide the General Assembly and social service providers advance notice prior to reducing, eliminating, or suspending services. ### **Thriving Youth Fund**

The Thriving Youth Fund bill, [SB2046/HB3217](#), establishes the thriving youth income tax check box that allows tax payers to fund non-Medicaid eligible community-based youth programs. ## **Funding Opportunities**

### **Charitable Trust Stabilization Fund**

The Charitable Trust Stabilization Fund is intended to help small non-profits, with annual budgets of \$1 Million or less. For the calendar year of 2017, the Charitable Trust Stabilization Fund will focus grant-making in three categories: Food Programs, Housing, and Workforce Development. Grants will be awarded twice in 2017. Applications will be accepted during two periods, from **February 1, 2017 through March 31, 2017** and from **July 1, 2017 through September 30, 2017**. Grant
