

## **Policy Update**

### FY18 Budget Proposal Eliminates 21st CCLC

The 21st Century Community Learning Centers (CCLC) initiative was not funded in President Trump's FY18 budget proposal. If eliminated, 456 communities serving 52,496 students in Illinois will be affected. ### Teen REACH Not Funded in FY18 Proposal

Teen REACH is a cost-effective out-of-school time prevention program that provides safe environments for youth and a unique, comprehensive array of supports including: academic assistance, life-skills building, mentoring, and job preparation. At its height, Teen REACH received \$20 million in funding and served 26,000 youth, meaning that 11,000 fewer students were being served by FY15. ### Social Services Contract Notice

The Social Services Contract Notice Act, <u>HB3110</u>, passed out of the House and is now in the Senate. This bill was written in response to the Good Friday social services cut that took place in April 2015. The bill would require the state of Illinois to provide the General Assembly and social service providers advance notice prior to reducing, eliminating, or suspending services. ### Thriving Youth Fund

The Thriving Youth Fund bill, <u>SB2046/HB3217</u>, is on its second reading in the Senate. # **Funding Opportunities**

### **Charitable Trust Stabilization Fund**

The Charitable Trust Stabilization Fund is intended to help small non-profits, with annual budgets of \$1 Million or less. For the calendar year of 2017, the Charitable Trust Stabilization Fund will focus grant-making in three categories: Food Programs, Housing, and Workforce Development. Grants will be awarded twice in 2017. Applications will be accepted during two periods, from February 1, 2017 through March 31, 2017, and from July 1, 2017 through September 30, 2017. Grant applicants located in Illinois Enterprise Zones or similarly depressed economic areas will receive special attention. For more information about eligibility and the criteria, click here.

### The Finish Line Youth Foundation

The Finish Line Youth Foundation funds community-based youth athletic programs and camps that emphasize active lifestyles, especially programs that serve disadvantaged and special needs kids. The foundation awards grants on a quarterly basis for programming, facility improvements, and unforeseen fiscal circumstances. The next grant deadline is **Friday, March 31, 2017**. ### NASA Summer STEM Funding

Invest For Kids provides support for children in Chicago who are facing social and economic challenges by directing funds to smaller organizations that have been in existence for three years and who have an annual operating budget of \$1 to 3 Million,

### Challenge America Grant

The National Endowment for the Arts Challenge America grant offers support primarily to small and mid-sized organizations for projects that extend the reach of the arts to underserved populations. Matching grants in the amount of \$10,000 are available for professional arts programming and for projects that emphasize the potential of the arts in community development. ### The Clif Bar Family Foundation

The Clif Bar Family Foundation awards small grants averaging approximately \$7,000 for general organizational support as well as funding for specific projects that align with one or more of the foundation's focus areas: promoting Earth's beauty and bounty; creating a robust, healthy food system; increasing opportunities for outdoor activity; reducing environmental health hazards; and building stronger communities.
