## Afterschool for Children and Teens

### Policy Update.

#### Sec. DeVos Senate LHHS Appropriations Subcommittee Hearing

On June 6th, Education Secretary DeVos testified in front of the Senate Appropriations Subcommittee on Labor, Health and Human Services, Education, and Related Agencies (LHHS) on the U.S. Department of Education FY18 budget proposal. Sec. DeVos justified the elimination of the 21st Century Community Learning Centers on the grounds that the program lacked evidence. In response, LHHS Subcommittee members expressed support for the initiative. For more information on the hearing, click [here](#).

#### Federal Budget Update

On May 23rd, the Trump administration released its full FY18 budget. The proposal eliminates or cuts funding to programs that are vital for children and families.

- Funding for 21st Century Community Learning Centers (21st CCLC), the only federally sponsored afterschool program, was proposed for elimination.
- Funding for the Child Care and Development Block Grant (CCDBG), which supports low-income working families with quality child care, was reduced by \$99 million. The \$5 million increase reported in the proposal is an error due to using the FY17 Continuing Resolution as the baseline rather than the FY17 Omnibus level.

#### 21st CCLC Funding

The 21st CCLC initiative serves 52,496 students in 456 communities in Illinois. Be advised of the following updates and opportunities to take action:

- The FY17 federal omnibus spending bill, [H.R. 244](#), that includes a \$25 million increase for 21st CCLC was passed on May 5th.
- The President's FY18 full budget proposal proposes the elimination of 21st CCLC. To call on Congress to protect funding for afterschool and summer learning programs in FY18, click [here](#).

- ISBE is documenting how proposed cuts in federal funding for FY18 will affect Illinois schools and communities. Current 21st CCLC grantees are encouraged to share their programs' impact stories, data, and talking points for letters of support with their district superintendents.

### **Illinois Budget Update**

- The Illinois General Assembly adjourned its regular legislative session on May 31st without approving a state budget for the third consecutive year. The current fiscal year, FY17, ends on June 30th. The General Assembly will now require a three-fifths majority vote, which will require bipartisan support, in order to pass a budget.
- On April 6th the Illinois House passed [HB109, HAM1](#), which amends/repeals appropriations to the stopgap budget covering the first six months of FY17. The total appropriated for After School Youth Support Programs for the second half of FY17 is \$17,917,400. It is unclear at this time if the Senate will be moving forward with this bill.
- The Illinois Senate's \$36.5 billion FY17 supplemental spending plan and FY18 budget, [SB6](#), passed on May 17th. The bill makes appropriations to agencies for costs incurred prior to July 1, 2017 and includes roughly \$13.5 million in funding for Teen REACH. - The Governor's FY18 budget proposal does not include funding for the Teen REACH afterschool program. To take action and tell the General Assembly to fund Teen REACH, click [here](#). ### **Social Services Contract Notice**

The Social Services Contract Notice Act, [HB3110](#), passed in both chambers on May 25th. The bill would require the state of Illinois to provide the General Assembly and social service providers advance notice prior to reducing, eliminating, or suspending services. ### **Prompt Payment Equity Act**

The Prompt Payment Equity Act, [HB3143](#), passed in both Houses on May 25th. The bill amends the State Prompt Payment Act to include state vendors providing prevention, intervention, or treatment services and supports for youth on behalf of the state. ### **Thriving Youth Fund**

The Thriving Youth Fund bill, [SB2046](#), passed in both Houses on May 31st. It establishes the thriving youth income tax check box that allows taxpayers to fund non-Medicaid eligible community-based youth programs. ### **Child Protection Improvements Act**

The federal Child Protection Improvements Act of 2017, [H.R.695](#), which would provide no/low cost national background checks for youth serving organizations passed out of the U.S. House of Representatives on May 22nd.

### **Juvenile Justice Reform Act**

The federal Juvenile Justice Reform Act of 2017, [H.R.1809](#), that provides funding for delinquency prevention programming passed out of the U.S. House of Representatives on May 23rd.

### **Strengthening Career and Technical Education for the 21st Century Act**

The Strengthening Career and Technical Education for the 21st Century Act, [H.R.2353](#), updates the Perkins career and technical education (CTE) legislation. The bill recognizes and supports the work afterschool and summer providers are doing to help students enter the workforce prepared and ready for well-paid, in-demand careers.

### **Trauma-Informed Care for Children and Families Act**

The federal Trauma-Informed Care for Children and Families Act of 2017, [S.774/H.R.1757](#), addresses the impact of toxic stress and trauma on childhood development.
