### Policy

#### Prompt Payment Act Reform Bill

On November 8, 2017 the Illinois General Assembly voted to override Governor Rauner's August veto of the Prompt Payment Act, [HB3143](#). The legislation amends the State Prompt Payment Act to include vendors providing prevention, intervention, or treatment services and supports for youth on behalf of the state. The Prompt Payment Act requires the state to provide payment in a timely manner for services rendered or compensate the contractor for prolonged delays.

#### FY18 Appropriations

To prevent a temporary government shutdown in December 2017 Congress will have to either pass a FY18 budget or another continuing resolution, which may extend into February 2018. Due to the uncertainty around the appropriations process it is crucial that supporters of 21st Century Community Learning Centers take action. Organizations can let their members of Congress know just how vital directing federal funds to these programs are to their districts by signing on to the Afterschool Alliance's [letter to Congress](#). The deadline to sign the letter is **Friday, November 17, 2017**.

#### Tax Cuts and Jobs Act

The Afterschool Alliance identifies several possible harmful impacts of the House Republicans Tax Cuts and Jobs Act on the afterschool field. They include:

- Cuts to a wide range of mandatory and discretionary spending including federal funding for afterschool programs
- Elimination of the state and local tax deduction (SALT-D), which may result in decreased revenue to fund K-12 and higher education, health care, and other services
- Increases to the child tax credit will not benefit low income, working families
- Elimination of the Dependent Care Assistance Plans and employer-provided child care tax credit

- Decreases in charitable giving deductions for many middle and upper middle class families, which could decrease donations to many non-profits

### **ED Withdraws Outdated Subregulatory Guidance**

As a result of the Regulatory Reform Task Force's findings, the U.S. Department of Education (ED) announced it will withdraw nearly 600 out-of-date pieces of subregulatory guidance on its books. ED intends that by removing these materials it will make it easier for schools, educators, parents, and the public to understand what guidance is still in effect.
