### Policy

#### Children's Cabinet Update

On March 8, 2018, the Governor's Cabinet on Children and Youth met in Chicago. You can find details and materials from the meeting [here](#). The Cabinet provided updates on its three current initiatives: reducing lead burden; increasing the early childhood workforce; and improving readiness for work through apprenticeships. The Cabinet also reviewed proposals and adopted the following projects: collecting data on childcare subsidies' effects on family self-sufficiency; greater cross-agency collaboration for systems involved youth; college & career readiness through transitional math and alternative high school equivalency (HSE) credentials; and statewide community-based mentoring network. Project leads and teams are forthcoming. In addition, the Cabinet approved the motion to develop the Governor's Cabinet Youth Commission that will be comprised of persons ages 14 to 25 representing the youth voice of the state agencies involved. The next meeting will be held on **Thursday, June 7, 2018**.

### Quality Standards in Action

The Illinois Statewide Afterschool Quality Standards encompass seven Core Areas, which capture practices that research demonstrates lead to quality programs and positive outcomes for children and youth.

Galva Jr./Sr. High School in Galva, Illinois, uses the Quality Standards booklet as a guide for helping to assess where their quality improvement efforts should be directed. As a result of attending a Quality Standards provider training, the 21st Century Community Learning Center at Galva Jr./Sr. High School is more intentional about Core Area 5: Family and Community Partnerships.
