Policy Updates

Public Act 096-0734

Public Act 096-0734, which amends Public Act 095-0155, requires a school district to implement a summer breakfast and/or lunch program for the duration of the summer school program in all schools where 50 percent or more of the student population is eligible for free or reduced-price meals and have a summer school program. This amendment applies to all schools that meet the aforementioned criteria, including those schools not currently participating in any federal Child Nutrition Program. Protecting Sensitive Locations Act

On February 6th, Representative Adriano Espaillat (NY-13) introduced a legislative package to protect immigrant rights. The package reintroduced the Protecting Sensitive Locations Act (H.R. 1011) which prohibits immigration enforcement in certain "sensitive locations" such as courthouses, schools, community centers and houses of worship. Illinois Minimum Wage

As of February 14th, a bill to raise Illinois' minimum wage to \$15 by 2025 needs only Gov. J.B. Pritzker's signature to become law, and his office said he stands ready to act in the coming days. To learn more, [click here](#).

Vote Equity Guide

The Vote Equity Project conducted an innovative survey to rank the legislative priorities of Chicago's citizens. Vote Equity then created a guide to help voters tell the difference between the 15 candidates for mayor and 159 candidates for city council, based on the issues that were voted as being the most important to Chicago's citizens.
