### Policy Updates

#### The 116th Congress: Key Afterschool Issues

As January winds down and with the partial government shutdown on hold at least until February 15th, it is a good time to look at the new 116th Congress: what are the priorities, what might get accomplished, and what are the challenges and opportunities ahead from the afterschool advocate's perspective. #### STEM Education Research Bill

Before the 115th Congress adjourned in December of 2018, the President signed the Innovations in Mentoring, Training, and Apprenticeships Act ([H.R. 5509](#)). This act provides \$40 million in funding for the National Science Foundation to provide grants to universities and community colleges for research into STEM education approaches and STEM-related workforce issues. The Afterschool STEM Hub published a memo to federal agencies in late January 2019 in response to the Trump Administration's 5-year STEM education strategy that was released in early December 2018. Research shows that high-quality afterschool programs can both support positive youth outcomes—including enhanced academic, social, and emotional skills—and prevent poor youth outcomes. This white paper provides program leaders, policymakers, and other afterschool stakeholders with a common approach for addressing three important developmental outcomes in childhood and adolescence: substance misuse and abuse, problem behaviors, and academic performance.
