## Policy Updates

### State Level

#### 21st CCLC RFP

The Illinois State Board of Education will be discussing a new 21st Century Community Learning Centers RFP at the ISBE Board meeting on January 15, 2020. The Board will vote to approve the release of this RFP in February. This means a new 21st Century RFP is coming soon. If you are interested in applying for a 21st Century grant, we recommend you start reviewing [past RFPs](#) and assembling your paperwork.

#### Funding for Youth Development Programs from Cannabis Legalization

With the legalization of recreational cannabis in Illinois, the state created a grant program to fund human services in the communities the hardest hit by the war on drugs. This program is called Restore, Reinvest, Renew (R3). One of the allowable uses of R3 funding is youth development programs, such as afterschool programs. Yesterday, the R3 Board met and approved the eligible areas for R3 funding. The Board will meet again in March to approve the NOFO for this funding.
