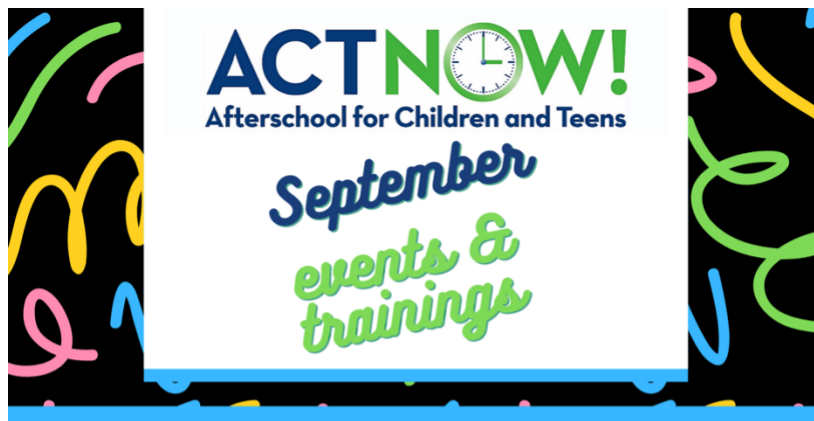

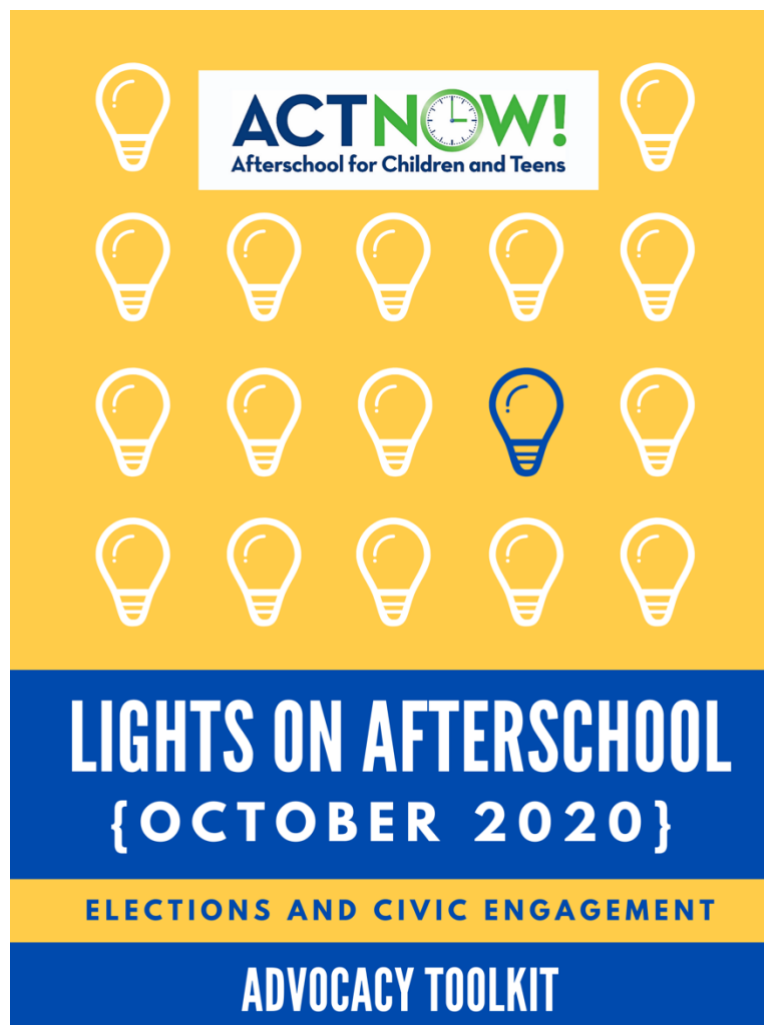


Lights On Afterschool 2020 Toolkit

Protecting Immigrant Families - Illinois: Upcoming Trainings Opportunities

Protecting Immigrant Families - Illinois (PIF-IL) is hosting two webinars in October in order to help afterschool providers, community-based organizations (CBOs) and communities better understand the Public Charge Rule that is now in effect in all 50 states. On **October 1, 2020 at 3:00 p.m. to 5:00 p.m.**, join PIF-IL for a webinar on the Public Charge Rule, which is geared towards leaders and service providers who serve immigrants who could be impacted by the regulation.
