# Policy Updates

## Federal Policy

### U.S. Department of Education: New CARES Act Funding Tracker

**Last week**, the U.S. Department of Education released a CARES Act education funding tracker that tracks in real-time the funds allocated to states and Lead Education Agencies (LEAs). ### Office of Child Care: Child Care Development Block Grant FAQ Update

On **November 13, 2020**, the Office of Child Care, which administers the Child Care Development Block Grant (CCDBG), updated its FAQ. One question in particular, (#29), surrounds the issue of whether Lead Agencies are allowed to use Child Care Development Funds to pay for subsidies for school-age children who participate in remote, virtual, or online schoolwork, while in child care. The Office of Child Care now allows states to be innovative in allowing CCDBG to fund community learning centers or "learning hubs" and supervised learning during the virtual school day. This new flexibility may encourage state and local entities to use this funding to further support youth as they continue with remote learning. To read the updated FAQ, click [here](#).

## State Policy

### Governor Pritzker's Office and the Illinois Department of Commerce and Economic Opportunity: New Digital Equity Package Announced

On **November 17, 2020**, Governor Pritzker and the Illinois Department of Commerce and Economic Opportunity (DCEO) Office of Broadband announced its new Digital Equity Package. The offices are engaging state, local, nonprofit, and philanthropic entities in order to address gaps in digital access, adoption, and affordability for high-speed internet access. These new plans to achieve digital equity for Illinois build on the Governor's Connect Illinois program, a \$420 million initiative, which aims to provide universal internet access throughout the state by 2024. The announcement elevates the **initial \$750,000 investment and will be used for complementary grants and programming to promote broadband planning and capacity building.**

- **Broadband READY Grants - Total of \$250,000:** Grants will be awarded to regional entities statewide to explore opportunities for equitable advances in the areas of broadband access, adoption, and utilization. More information and the Broadband READY Grant NOFO can be accessed [here](#).
- **Illinois Connected Communities Grants - Total of \$150,000:** The latest round of the Illinois Connected Communities Grants will allow communities to apply for up to \$15,000 in grants to support community-based broadband planning and capacity building initiatives. - **Digital Navigator Collaboration:** To support community digital equity needs, the Office of Broadband is partnering with the National Digital Inclusion Alliance (NDIA) and PCs for People to establish digital navigator capacity within communities in Illinois. ### **Illinois State Board of Education: 21st Century Waiver Application Approved by U.S. Department of Education**

On **November 10, 2020**, the Illinois State Board of Education's (ISBE) 21st Century Waiver application was approved by the U.S. Department of Education. On **November 23, 2020**, ISBE confirmed this news with ACT Now. The State Education Agency now has the ability to approve 21st CCLC subgrantees in Illinois to provide supplemental activities when school is in session but students are not receiving in-person instruction, such as by permitting a teacher to provide additional academic supports during remote learning. ### **Illinois State Board of Education: November Board Meeting Recap**

On **November 19, 2020**, the Illinois State Board of Education (ISBE) met for its monthly board meeting. The Board heard extensive public comment on the Illinois Preparation Profile (IPP) system, the End of Year State Assessment, and Special Education Rules. Board members and public participants expressed their concern about the goal of assessing students during an ongoing public health crisis, as there are already so many challenges. Superintendent Dr. Ayala clarified that a state assessment would not be applied for accountability measures but rather to assess the whole needs of students with regard to: Learning losses, Widening opportunity gap, Equity, Digital Divide, Trauma and Social-Emotional Learning (SEL) supports, and more. Board members also heard presentations from two school districts on District Intervention Funding

and participated in a walk-through of the IPP website. The Board then discussed the development of Spanish Language Arts Standards and the revision of the Social Science Standards Recommendations after hearing from working groups. The Board also voted to approve the agency's Strategic Plan and named the 2020 Thomas Lay Burroughs Award Recipient. ### **Chicago Public Schools: Quarter II Reopening Plan for 2021 Announced**

On **November 17, 2020**, Chicago Public Schools (CPS) announced that it will go forward with its plan to reopen institutions throughout the school district, beginning in January 2021. Pre-K and students with disabilities are being prioritized after many families have indicated that remote learning has proven extremely difficult. Over the past several weeks, CPS has disseminated surveys to families with Pre-K and special education students in order to assess the level of interest in having their children return to in-person instruction. The Quarter II reopening plan is as follows:

- On **January 4, 2021**, Pre-K and cluster staff are scheduled to return to their institutions.
- On **January 11, 2021**, Pre-K and cluster students start in-person instruction.
- On **January 25, 2021**, K-8 program staff will return to their school buildings.
- On **February 1, 2021**, K-8 students begin in-person instruction.

#### **Afterschool Alliance Brief: Back to School in the Time of COVID-19**

[The Afterschool Alliance](#) has released its third brief with survey data from afterschool providers, in order to emphasize the challenges brought upon by the COVID-19 pandemic and highlight the field's innovations as programs continue to respond to it. The Afterschool in the Time of COVID-19 Wave 3 survey finds that afterschool programs have needed to adapt to the various school reopening scenarios that are being implemented across the country. When asked about the types of supports being provided in response to COVID-19, a majority of programs (53%) report taking on a new role necessitated by COVID – providing a safe, supervised learning environment during virtual school days. 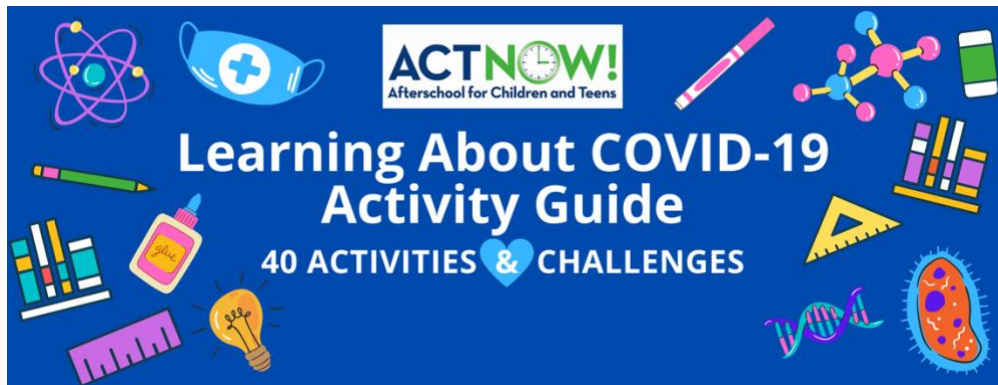
#### **American Youth Policy Forum Blog Post: The Importance of Healing-Centered Afterschool Programs in the COVID-19 Era**

[The U.S. Department of Agriculture](#) has developed the Community Connect Program, which aims to help rural communities extend access where broadband service is least likely to be commercially available. The projects funded by these grants help rural residents tap into the enormous potential of the Internet for jobs, education, healthcare, public safety, and community development. Grants can be used for

- the construction, acquisition, or leasing of facilities, spectrum, land or buildings used to deploy broadband service for all residential and business customers located within the Proposed Funded Service Area (PFSA)
- All participating critical community facilities (such as public schools, fire stations, and public libraries)
- The cost of providing broadband service free of charge to the critical community facilities for 2 years.
