Policy Updates

Federal Updates

[Congress Supports Afterschool STEM Learning Opportunities in Legislation](#)

In **May**, Congress began negotiating a bill to address the nation's competitiveness as it relates to STEM learning and technology and trade occupations. 107 members of Congress (26 Senators and 71 House members) were "charged with reconciling differences between the House's [COMPETES](#) Act and the Senate's [USICA](#) legislation." [The Afterschool Alliance](#) reports that Afterschool STEM opportunities were included in both pieces of legislation and there is hope that they will remain a part of the final bill.

State Updates

[Illinois Plan to Support Families Is In Effect!](#)

On **July 1, 2022**, Governor JB Pritzker announced that the Illinois Family Relief Plan went into effect. This plan totals \$1.83 billion and aims to "provide relief on the grocery tax, gas tax, and property taxes" for individuals and families across the state. Within this plan:

- **Groceries:** The state's 1% sales tax on groceries will be suspended July 1 through June 30, 2023, saving consumers \$400 million.
- **Gas:** The state's normally scheduled increase in the motor fuel tax will be delayed from July 1 to January 2023, saving consumers \$70 million.
- **School supplies:** Sales taxes for qualified clothing and school-related items will be reduced from 6.25% to 1.25% for a 10-day window from August 5 to 14, saving consumers \$50 million.

[Chicago Public Schools 2022-2023 Budget Passed](#)

On **June 23, 2022**, Chicago Public Schools' (CPS) Board of Education approved the district's \$9.4 billion budget for the 2022-23 school year. This is about \$200 million more than the previous school year's budget and aims to cover operational costs, improvements to infrastructure, and the school district's debts. CPS leadership also announced that almost half of the district's budget will go directly to schools' budgets and encouraged local school administrators to manage resources as COVID-19 relief is set to expire in 2024. According to [Chalkbeat Chicago](#), "parents and union leaders argue that schools are still not getting what they need to address academic and mental health fallout from the pandemic."

[DFSS Enrichment School-Year Program Request for Proposal \(RFP\)](#)

[The City of Chicago's Department of Family and Support Services \(DFSS\)](#) is soliciting applications from organizations in order to fund implement safe, supportive, interactive, and engaging youth development activities, primarily for youth who are underrepresented. Enrichment School Year programs must operate at least 300 hours a year and align with the school year calendar, providing programming during winter and spring break. **Awards begin at \$48,000 and the deadline to apply is July 26, 2022.**

[FY23 Early Childhood Block Grant Awards](#)

The Illinois State Board of Education (ISBE) will be using applications submitted for the FY21 Early Childhood Block Grant competition to identify awardable programs as determined in the Request for Proposals. ISBE will be prioritizing entities that

- propose to offer services to children who reside in Tier 1 or Tier II district boundaries
- can document that there is an insufficient number of classrooms to fully serve at least 80 percent of all children and families who potentially could be at risk. This would include communities with the highest need and least saturation.

In particular, the funding awarded will reflect the cost of operating a program for a minimum of 165 student attendance days per year; it is possible that applications may not be awarded for the full number of slots requested.
