## Policy Updates

### Federal Updates

#### [Summer Meal Waivers and Flexibilities Pass in Congress and Start to Roll Out](#)

[The U.S. Department of Agriculture's \(USDA\) Food and Nutrition Service \(FNS\)](#) recently issued several waivers and flexibilities related to the national child nutrition program. These actions were a direct result of the Keep Kids Fed Act of 2022, which aimed to continue and expand the provision of meals for students (as waivers first introduced at the start of the COVID-19 pandemic were set to expire). These rules will allow Out-of-School Time (OST) programs, schools, and other community-based organizations that offer meals to youth to operate during Summer 2022 and School Year 2022-2023. The following are flexibilities provided in the Keep Kids Fed Act of 2022:

- **Area Eligibility:** allows meals to be offered through the Summer Nutrition Programs at sites that do not meet the 50 percent area eligibility requirement
- **Meal Times:** allows meals to be served outside traditional times to maximize flexibility for meal pickup
- **Non-Congregate Feeding:** allows meals to be served in a non-group setting (i.e., allowing for “grab and go” and delivered meals)
- **Parent/Guardian Pick-Up:** allows parents or guardians to pick up meals without children being present;
- **SFSP Reimbursement for Meals Served Under SSO:** allows schools operating the Seamless Summer Option (SSO) to receive the higher Summer Food Service Program (SFSP) reimbursement for meals served this summer
- **Eligibility for Closed-Enrolled Sites:** allows all closed-enrolled sites to participate without individually qualifying each child

The Keep Kids Fed Act also makes available additional funding for child nutrition program operators by:

- Providing afterschool meal providers and child care centers with a temporary supplement of 10 cents reimbursement per meal and snack
- Providing schools with a temporary supplement to reimbursement of 40 cents per lunch and 15 cents per breakfast
- Providing family day care homes with the higher (“Tier 1”) reimbursement rate for school year 2022-23
