Policy Updates

Federal Updates

[Biden Signs Spending Bill That Averts Government Shutdown](#)

President Joe Biden signed an interim funding bill on **September 30, 2022**, preventing a government shutdown on the last day of the fiscal year. The continuing resolution keeps the government funded through December 16th, giving lawmakers more time to pass Fiscal Year

2023 funding bills. Appropriators likely will wait until after the November 8th election to start negotiating on an FY 23 spending bill. Congress is out on recess until mid-November.

[Tax Credit for Student Parents Act](#)

On **September 29, 2022**, U.S. Representatives Kim Schrier, M.D. (D-WA) and Peter Meijer (R-MI) introduced the Tax Credit for Student Parents Act. This bipartisan bill will make sure that student parents who are working to get a post-secondary degree, including vocational school and two and four-year universities, are eligible to receive the [Child and Dependent Care Tax Credit](#) (CDCTC), which helps to offset working families' child care expenses.

[Extended Deadline for CARES Funding](#)

The [United States Department of Education](#) released a memo on **September 29, 2022** stating that schools can apply for a 14-month extension to extend the deadline to spend CARES Act funding. The previous deadline was September 30, 2022.

Funding Opportunities

Administrators

[Afterschool Programs Grant](#)

The [Illinois State Board of Education](#) appropriated \$20 million for FY 2022 in General Revenue funds to provide the After School Programs Grant to school districts and community organizations for after-school programming, as well as other programming outside of the normal school day. The After School Programs Grant is a two-part initiative. School district grant allocations total \$17 million out of the \$20 million appropriated. Another \$3 million is competitive grant allocations for non-school district applicants.

[Cook County Promise Pilot](#)

[Cook County](#) is launching this two-year pilot program to offer stability and opportunity for financial growth to eligible Cook County residents. An open application and lottery will select 3,250 residents to receive \$500/month for 24 months. Apply by **October 21, 2022!**

[Mentoring RFP Application Period Extended](#)

[The Department of Family Support & Services](#) released an update stating the Mentoring RFP application period has been extended until Friday, **October 14, 2022, at 12:00 p.m.** There is a [new amendment](#) that applicants will be required to acknowledge if they have already started their application.
