On **Saturday**, **May 2**, **2020** the State of Illinois announced it was expanding the availability of COVID-19 testing and that that a new drivethru COVID-19 testing facility will be open to the public in the coming days.

All individuals with symptoms are encouraged to seek testing at these Community Based Testing Sites. Additional accommodations have been made for testing for various industries including childcare workers.
