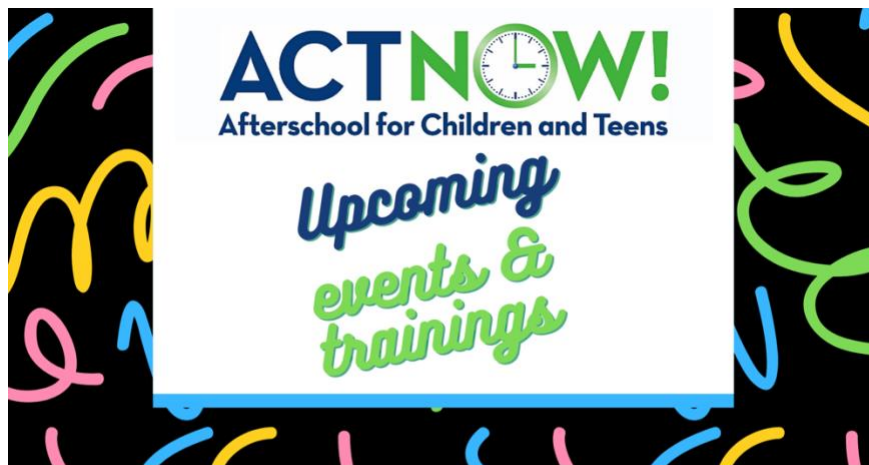

Policy Updates

State Policy

Illinois State Board of Education: 21st Century Waiver Public Comment Period Clarification

On **September 18, 2020**, State Education Agencies (SEAs), including the Illinois State Board of Education (ISBE), received the template to apply for the U.S. Department of Education's 21st Century waiver. **This waiver provides 21st Century Community Learning Center (21st CCLC) grantees with the ability to facilitate programming and provide support services during the school day.** The U.S. Department of Education mandated a 60-day period for public comment on the waiver before allowing SEAs to submit their requests. **Last week, ISBE released its call for Public Comment on the waiver. Comments must be submitted via the 21st CCLC Waiver Form no later than 4:00 p.m. on October 29, 2020.** For more information on the waiver, click [here](#).
