Funding Opportunities

[Funding for Students Experiencing Housing Insecurity](#)

[The Illinois State Board of Education \(ISBE\)](#) will be allocating \$38 million in federal funding to identify and support students experiencing housing insecurity, including \$33 million from the American Rescue Plan Homeless Children and Youth Part II grant. The funding will bolster schools' efforts to identify students in temporary living situations and provide them with services. ISBE has shared local education agency's (LEAs) allocation of funding, which can be accessed [here](#). Per federal guidance, LEAs allocated less than \$5,000 in funding as stipulated by the

formula are not eligible for the subgrant on their own. To receive a subgrant, the LEA must join a consortium of LEAs in which the sum of its members' allocations meets the \$5,000 threshold. Access the application in the Electronic Grants Management System. **ISBE's McKinney-Vento coordinator will provide an overview of how the funding can be used and answer questions about the application on [December 9, 2021, at 2:00 p.m.](#)**
