# **Policy Updates**

## **Federal Policy**

U.S. Department of Education: 2020-2021 Waiver on Accountability Measures for State Education Agencies Announced

On **February 22, 2021**, the U.S. Department of Education announced that it is soliciting applications from State Education Agencies (SEAs) for a waiver on 2020-2021 Accountability measures. **The Illinois State Board of Education (ISBE) stated that it will be applying for waiver for the 2020-2021 school year.** The U.S. Department of Education noted that any state receiving this waiver would not be required to implement and report the results of its accountability system. Unfortunately, the U.S. Department of Education did not release a waiver for 2020-2021 school year Assessments but is encouraging SEAs to provide flexibility in the administration of statewide assessments in the following ways:

- Administering a shortened version of its statewide assessments
- Offering remote administration, where feasible
- Extending the testing window to the greatest extent practicable, including into summer or even the beginning of the 2021-2022 school year

ISBE announced that the state agency will apply for the maximum flexibility available, including seeking the available waivers for summative designations and the 95 percent assessment participation requirement.

Congress: Full Service Community Schools Expansion Act of 2020 Reintroduced in House and Senate

**Last week,** the <u>Full Service Community Schools Expansion Act of 2020</u>was reintroduced in Congress.

**Congress: Summer Meals Act of 2021 Reintroduced in House** 

On **February 3, 2021,** the <u>Summer Meals Act of 2021</u> was reintroduced in the U.S. House of Representatives by Representatives Young (R- Arkansas) and Larsen (D-Washington). The U.S. Senate version of this bill is scheduled to be reintroduced by Senators Murkowski (R- Arkansas) and Gillibrand (D- New York) in the coming weeks. Furthermore, the Senate Agriculture Committee is starting the Child Nutrition Reauthorization period, which is the

process when Congress reviews and updates laws that govern all child nutrition programs including school lunch and breakfast, summer meals, and after-school meals. Senator Durbin (D- Illinois) sits on the Senate Agriculture Committee.

# **Governor Pritzker's Office: United Center COVID-19 Vaccination Site To Be Opened March 10**

On **February 26, 2021,** in a joint announcement with the Biden Administration, Cook County Board President Preckwinkle, Chicago Mayor Lightfoot, and Senators Durbin and Duckworth, Governor JB Pritzker, shared that **eligible Illinoisans from every part of the state will be able to be vaccinated starting March 10, 2021, at the United Center. # Governor Pritzker's Office: Legislation Signed Into Law that Protects First Responders and Frontline Essential Workers

On **February 26, 2021,** Governor JB Pritzker signed <u>HB 4276</u> into law, which extends worker compensation benefits until **June 30, 2021,** for first responders and frontline essential workers who were exposed to and contracted COVID-19 through their job. This legislation also allows employees to take extended time-off to up to 60 days if COVID-19 impacted the recovery of the individual. To learn more about this law, click <u>here</u>.

# Governor Pritzker's Office: Governor JB Pritzker Expands Eligibility of Phase 1B to Include Illinoisans with Serious Medical Conditions

On **February 25**, **2021**, Governor JB Pritzker and the Illinois Department of Public Health announced that Illinoisans with serious medical conditions will be prioritized for COVID-19 vaccinations. **Eligible individuals include Illinois residents 16 and older with disabilities or underlying serious health conditions who aren't otherwise covered in previous eligibility categories, in accordance with CDC guidelines.** To access the full list of underlying health conditions, click <u>here</u>.

# **Governor Pritzker's Office: Youth Career Pathways Program Notice of Funding Opportunity Released**

On **February 24, 2021,** Governor JB Pritzker stated that Illinois will be providing new funding for the Youth Career Pathways program that will expand training for Illinois youth who face barriers to education, training, and employment. Through a Notice of Funding Opportunity (NOFO) released by the Department of Commerce and Economic Opportunity (DCEO), the state will expand access to training and support services for youth ages 16-24 and who are most at-risk for falling behind on career preparation. **Applications for the NOFO are due April 1, 2021, at 5:00 p.m.** To learn more about this funding opportunity apply for the NOFO, click **here**.

# **Governor Pritzker's Office: Illinois Children Will Receive Monthly Food Aid Starting in March**

On **February 23**, **2021**, Governor JB Pritzker and the Illinois Department of Human Services shared that beginning this month, approximately one million children across the state will receive additional food benefits, valued at up to \$110 million per month. This support, funded by the U.S. Department of Agriculture's Food and Nutrition Service, is expected to reach 200,000 more eligible children this school year compared to last year. Students eligible will automatically receive these benefits on an "EBT Card" mailed directly to their homes. The funding will be distributed by the Illinois Department of Human Services (IDHS) in partnership with the Illinois State Board of Education (ISBE) to students who are eligible for Pandemic Electronic Benefit Transfer (P-EBT) support.
