# **Policy Updates**

## **Federal Policy**

**U.S. Senate: American Rescue Plan to Provide Funding for Afterschool and Summer Learning Providers** 

On March 6, 2021, the U.S. Senate joined the U.S House of Representatives in passing President Biden's <u>American Rescue Plan</u>, which supports afterschool and summer learning providers. In total, the Senate bill could make \$8.75 billion available for afterschool and summer programs, across all states, which would be administered by State Education Agencies (SEAs). Funding at this level, will potentially provide opportunities for more than 9 million young people across the country. There will also be \$21.9 billion

available for afterschool and summer programs, administered by local school districts. This bill was revised by the Senate and the House is expected to pass it before sending it to President Biden to sign into law later this week. ## **State Policy**

#### Governor Pritzker's Office: Education and Workforce Equity Act Signed into Law

Yesterday, on March 8, 2021, Governor JB Pritzker signed the Education and Workforce Equity Act (<u>HB 2170</u>) into law, which aims to strengthen the state's priorities in delivering high-quality learning for early-learners and K-12 students by supporting public schools, making college education more affordable, investing in vocational training, and expanding the teacher workforce. As it relates to the afterschool field, the Act requires the Illinois P-20 Council to make recommendations for both the short-term and long-term learning recovery actions for students in the wake of the COVID-19 pandemic. It also creates the Whole Child Task Force, which will focus on expanding trauma-responsive school services. To read the full press release, click <u>here</u>.

#### Illinois Department of Human Services: The Child Care Restoration Grants 2021 Program Now Open

Last week, the <u>Illinois Department of Human Services (IDHS)</u> announced that the agency is soliciting applications for the agency's Child Care Restoration Grants 2021 program (CCRG). This \$331 million program is funded by the federal relief package passed by the US Congress and exists in order to sustain child care as the economy continues to reopen. The CCRG 2021 first round of grants will be retroactive to January 2021 and cover the months of January, February, and March 2021. Monthly reporting will be required and can be submitted at the end of the 3-month grant period. Eligible applicants include:

- Licensed child care center providers
- Licensed family home and group home providers
- License-exempt school-age child care providers and Out-of-School Time (OST) providers

Please note that the amount of funding differs between the groups of providers.

- Licensed child care center providers will receive grants on a quarterly-basis and as funding is available.
- Both licensed family home and group home providers, as well as license-exempt school-age child care
  providers and OST providers, will receive limited one-time stipends for the months of January, February,
  and March 2021.

#### City of Chicago: Guidance on Out-of-School Time Programming

Last week, the <u>Chicago Department of Public Health</u> released new guidance as it relates to COVID-19 restrictions and Out-of-School Time (OST) programming. OST providers are now allowed to host indoor group exercise or fitness classes capped at 20 individuals (e.g., dance, yoga). Programs in which participants are primarily seated/stationery may continue in cohorts of up to 20 people (e.g., painting, creative writing, homework help). Day camps are still limited to 50% of facility capacity with no more than 15 participants per group. To learn more, click <u>here</u>.
