## Policy Updates

### Federal Updates

#### [FY23 Budget Update](#)

[The Afterschool Alliance](#) released a brief update on the federal FY23 budget process. There appears to be increased support for 21st Century Community Learning Centers (21st Century) with President Biden proposing \$21 million more in funding for the grant program. Within the FY23 proposed budget there are also historic amounts for federal education funding. In addition to the appropriations hearings in the House of Representatives, late last month Rep. David Cicilline (D-R.I.), co-chair of the House Afterschool Caucus, sent a [bipartisan Dear Colleague letter](#) in support of out-of-school time (OST). There was also a letter of support sent to the House Labor, Health and Human Services and Education Appropriations Subcommittee to encourage members to increase 21st Century.

#### **Illinois Quality Program Self-Assessment (IL-QPSA) Support**

**ACT Now's** online self-assessment system, the IL-QPSA, has recently been experiencing some technical difficulties. If you are a user that should have been sent an email from the IL-QPSA system prompting you to create a login and password or you had requested a new password, please follow the following detailed instructions below:

- Please note that Google Chrome works best
- In your browser settings, disable cookies/cache
- Use this link to access the system: <https://ilqpsa.actnowillinois.com/admin/login.html>
- Click 'Forgot Your Password?'
- When you try to set the password: does it indicate that it is a 'good' or 'strong' password?
- If the password is 'poor,' then it will not save. Try setting another password.
- Then, follow the necessary prompts between the system and your email account
