Policy Updates

Federal Updates

[Chalkbeat Chicago Article: Head Start Grant for City of Chicago Redistributed by Federal Government](#)

On **July 20, 2021**, the federal government shared that it will be breaking up the City of Chicago's "monopoly" of the \$145 million Head Start grant program and redistribute almost \$95 million in grants to five community-based organizations across the city. One of the grantees will be led by former Illinois First Lady Diana Rauner and City Hall will remain in control of \$51.8 million of the grant. The new federal grantees will also oversee a small group of partner agencies, with Start Early's roster including two charter schools that run preschool programs and kindergartens. Our colleague, Bela Moté, the CEO of the Carole Robertson Center for Learning, said her organization will "focus immediately on doing more to [boost salary and benefits for educators](#) and help stem the loss of teachers to the public school district, where pay is on a unionized pay scale."

State Updates

[P-20 Council: July Meeting Recap](#)

On **July 23, 2021**, the P-20 Council met for its monthly convening. The P-20 Council announced that it would be writing a report on learning renewal pursuant to [HB 2170](#). There will be opportunities for stakeholder participation in writing this report. **ACT Now** provided public comment about the need for greater school district and community organization collaboration in learning renewal and mentioned our upcoming webinars on this topic. The next P-20 Council meeting is **September 24, 2021**.

[Chicago Public Schools: Masks for Unvaccinated Personnel and Youth Will be Mandatory for School Year](#)

On **July 22, 2021**, Chicago Public Schools (CPS) representatives announced that **masks will be mandatory for school personnel, visitors, and youth, regardless of their vaccination status**. Masks will not be mandatory for youth while eating or drinking indoors, or for outdoor activities including recess and sports. This change in regulation will span the entire school year to ensure that students and educators remain safe from COVID-19. However, district officials stated they cannot guarantee three feet of social distancing within school premises at all times given the student population and classroom constraints.

[Culturally responsive practices: Insights from a high-quality math afterschool program serving underprivileged Latinx youth](#)

[The American Journal of Community Psychology](#) has published an article on how culturally responsive practices are necessary to achieve high-quality and equitable science, technology, engineering, and mathematics (STEM) afterschool programs. The overall purpose of the study was to identify and examine culturally responsive practices in the context of a high-quality university math enrichment afterschool program serving approximately 120 low-income LatinX middle school youth from underserved schools in Southern California.

This year alone more than 250 anti-LGBTQ bills have been introduced in states across the country, many of which directly affect young people. In 2020, the Centers for Disease Control and Prevention (CDC) released the national [Youth Risk Behavior Surveillance](#) report showing that LGBTQ students are more likely to be bullied than their straight, cisgender classmates. In response, the [Afterschool Alliance](#) has written an article with five strategies for supporting LGBTQ youth in out-of-school time environments.
