### Policy Updates

## Federal Updates

### [U.S. House of Representatives: National Science Foundation for the Future Act Passed!](#)

On **June 28, 2021**, the U.S. House of Representatives passed the National Science Foundation for the Future Act. This legislation addresses challenges at all levels of STEM education and training by supporting partnerships with community-based organizations (CBOs). The Act also broadens current projects funded by the National Science Foundation (NSF). Finally, this bill establishes a new directorate to accelerate progress on emerging technologies and advance research-driven solutions to societal challenges like climate change and inequality.

### [Biden Jr Administration Press Release: Youth Development Programming as a Comprehensive Strategy to Prevent and Respond to Gun Crime and Ensure Public Safety](#)

On **June 23, 2021**, President Biden released a statement emphasizing how youth development programming, such as summer programming, may help prevent violence that takes place over the summer. The press release also highlights the importance of providing employment opportunities, and other services and supports for teenagers, young adults, and formerly incarcerated individuals. The document shares guidance on using American Rescue Plan (ARP) funds to reduce violence. President Biden also announced that the Administration will convene and support a CVI Collaborative of 15 jurisdictions that are committing to use a portion of their ARP funding or other public funding to increase investment in their CVI infrastructure, including to anticipate and respond to the potential rise in violence this summer. Chicago, Illinois is included in this new initiative.

### [Afterschool Alliance: Draft State Child Care Plans for 2022 to 2024 Announced](#)

[The Afterschool Alliance](#) has created a website highlighting states' draft child care plans for 2022 to 2024. The plans were due **July 1, 2021**, and will now be reviewed by the Office of Child Care. The finalized versions will go into effect **October 1, 2021**. These plans support programs for children and youth ages 0 to 13, including afterschool and summer programs.

## State Updates

### [Governor JB Pritzker's Office: Expansion of Financial Support for Families Accessing Child Care and Program Providers](#)

On **June 29, 2021**, Governor JB Pritzker announced that he will be expanding financial assistance for both families and providers that allow children to return to quality, affordable child care programs. Under this change, 80% of families will pay less for child care via the Child Care Assistance Program (CCAP), administered by the Illinois Department of Human Services (IDHS). Financial assistance includes:

- **Reducing family payments:** Family payments will be permanently lowered to \$1 per month for families with incomes at or below 100% of the Federal Poverty Limit (FPL). 80% of all families will see a reduction in their monthly co-pay.
- **Preserve co-pay percentage limits:** Family payments will remain permanently capped at 7% of family income, with co-pays for 80% of families falling below that rate.
- **Supporting families as their income grows:** CCAP families will now remain eligible until the family's income surpasses 250% of the Federal Poverty Level (FPL), instead of the current cap of 225%.
- **Increasing reimbursement rates:** All CCAP providers will now receive 3.5% for reimbursements to help providers keep their doors open and fully recover from the pandemic.
- **Improving predictability for providers:** If a child receiving CCAP attends at least 70% of eligible days in a month, providers will be paid for the full month. The previous policy required an 80% attendance rate.
