Toolkit: Partnering on Career & Technical Education

The Strengthening Career and Technical Education (CTE) for the 21st Century Act (Perkins V) was signed into law on July 31, 2018. The bipartisan legislation offers new opportunities to connect the work of afterschool and summer programs to state and local CTE initiatives. The Afterschool Alliancehas created a toolkit to provide afterschool stakeholders and
