### ISBE Board Meeting Recap

On April 17, 2019, the Illinois State Board of Education met for their monthly meeting. You can find the board packet [here](#). The Board spent the majority of the meeting assessing and addressing the Illinois teacher shortage. The Board then heard public comments around the CPS Special Education Corrective Action plan, as well as legislation regarding the Illinois teacher shortage. Additionally, the Board approved a new budget recommendation that includes an amended line item for district intervention. Aside from that amendment, ISBE's budget recommendation still mirrors the Governor's budget and does not include afterschool programs and community schools. **We encourage you to continue sending messages to your legislators supporting afterschool programs and community schools by [clicking here](#).** The Board will meet next on May 15, 2019.
