Bills Introduced Addressing Trauma/ACEs

A brief published by [Child Trends](#) reports that 45 percent of youth in the United States have experienced at least one [adverse childhood experience \(ACE\)](#). ACEs refer to a set of experiences, which can include abuse, neglect, and trauma, that are linked with negative health outcomes and behaviors. Several newly introduced bills on Capitol Hill address childhood trauma, social and emotional learning, and the role that afterschool programs can play in protecting against and addressing trauma, including the [RISE from Trauma Act](#), the [Mental Health Services for Students Act](#), and the [Success in the Middle Act](#).
