Rebuild America's Schools Act

On January 30th, House Education and Labor Committee Chairman Bobby Scott (D-VA) introduced <u>H.R.865</u>, the "Rebuild America's Schools Act." The bill would create a \$70 billion grant program and \$30 billion tax credit bond program to improve schools in high-poverty areas; develop a comprehensive national database on the condition of public school facilities; and expand access to high-speed broadband internet. Scaling Education Pathways in Illinois

Scaling Education Pathways in Illinois (SEPI) is an initiative to address the teacher shortage in the state by creating community collaborations to build education career pathways in public schools, facilitating a student's progression from pupil, to teacher, to instructional leader. The SEPI Request for Proposals (RFP) provides community collaborations with the opportunity to receive up to \$14,000 to establish a continuum of supports and pathways for new teachers that addresses placement and mentorship.
