Policy Updates

Governor Pritzker on Community Schools

During his inaugural speech, Governor JB Pritzker addressed the need for community schools in Illinois by stating: "We will approach education with a holistic mindset – recognizing that students do best in community schools where teachers are paid well and where kids start learning at the earliest ages. How the Shutdown Is Starting to Impact Schools

The current government closure is different from earlier shutdowns because the agencies from which school districts receive critical federal dollars—chiefly the

ISBE Budget Recommendations

ISBE has just released their Budget Recommendations. These recommendations include funding for Afterschool Matters, After School Programs, Healthy Communities Investment Grants, and Community Schools. The Superintendent recommends a \$15 million appropriation for Community Schools for FY20. This recommendation directly quotes ACT Now's recent testimony at the 2018 ISBE budget hearings as the primary evidence supporting this line item. Opportunity Scholarship for DREAMers

The Opportunity Scholarship for DREAMers was developed for students who live in states where they effectively have no access to college – either because they face paying out-of-state tuition or because their state will simply not admit them into its universities. This scholarship award will cover tuition, fees, and on-campus housing and meals at one of BOOST Cafe's partner colleges (up to a maximum of \$80,000 for a bachelor's degree). Healthy Communities Investment Grant

The FY19 Healthy Communities Investment Grant (HCIG) application is open. HCIG funding is provided for collaborative approaches between community-based organizations and schools to bridge support services that are sustainable for children and families to help ensure students are present, focused, and ready to learn in the classroom, including through afterschool and summer-learning programs.
