#### **Summer Learning Week & Summer Meals**

Summer isn't just about enrichment opportunities for kids, it's also is about ensuring our most vulnerable youth have access to good nutrition. During this National Summer Learning Week, we want to highlight the Summer Learning and Meals Act, which is to be reintroduced by U.S. Senators Jeff Merkley and Ron Wyden of Oregon and U.S. Representative Joseph Morelle of New York's 25th District. The new legislation would create a new federal grant program that provides grants to state libraries to allow schools with summer lunch programs to also keep their libraries open for student use during the summer months. By dedicating one day specifically to nutrition and wellness (July 13th), the National Summer Learning Association draws attention to the fact that the inequities of summer also extend to food security.
