

# **Policy Updates**

### **President Trump Proposes to Eliminate Afterschool**

On March 11, 2019, President Trump called for eliminating federal funding for local afterschool and summer programs. These eliminations would include the Supporting Effective Instruction State Grants, 21st Century Community Learning Centers, and Federal Supplemental Educational Opportunity Grants. If the funding is not maintained, over 50,000 children and families in Illinois would be left without reliable afterschool choices. Use this <u>action alert</u> to tell Congress that eliminating afterschool funding is unacceptable!

#### **Trauma-Informed Schools Act**

In December 2018, Rep. Katherine Clark (D-MA-5) introduced the Trauma-Informed Schools Act (<u>HR7320</u>). The bill would, for the first time, provide a definition in federal education law for what it meas to be trauma-informed. It also provides a special emphasis on Title I schools in efforts to be trauma-informed.
