State of the Union 2018

On Tuesday, January 30th, President Donald Trump delivered his State of the Union Address. President Trump did not mention afterschool or speak much about education. However, the President did mention his \$1.5 trillion infrastructure package. It is unclear if school construction will be part of this package. There are concerns that any increase in non-defense discretionary spending will go to this infrastructure package rather than vital education programs. President Trump also spoke about the importance of career and technical education, which is strengthened by many afterschool partnerships. Moreover, the President touched on the opioid crisis. Afterschool programs are critical for drug use prevention, but prevention was not discussed in the address. The President's budget is expected to be released in mid-February.

The Higher Education Act

The Higher Education Act of 1965 (HEA) is the nation's primary law with respect to postsecondary education. On December 13, 2017, the House of Representatives' Committee on Education and the Workforce, approved H.R. 4508, the Promoting Real Opportunity, Success, and Prosperity through Education Reform (PROSPER) Act. The bill repeals Title II, which provides supports and accountability structures for teacher preparation and building educator capacity in high-need fields, and streamlines the student financial aid system. STEM advocates caution that repealing Title II will negatively affect the STEM teacher career pipeline. In response, they are encouraging Congress to support incentives for both STEM career professionals and recent graduates to pursue teaching. Democratic House leaders are in the process of drafting their own reauthorization

language.
