### Policy

#### Federal Budget Update

On February 9, 2018, both the Senate and the House passed a fifth continuing resolution (CR) attached to a bipartisan budget deal. The recent CR ended a brief shutdown to keep the government open at FY17 levels through March 23rd. The budget deal raises the FY18 non-defense and defense spending caps over a two year period. It extends the recent reauthorization of the Children's Health Insurance Program (CHIP) by four years and includes a \$5.8 billion commitment for the Child Care and Development Block Grant (CCDBG). The FY18 omnibus spending bill is expected to be voted on in the coming weeks. Once in place, appropriators will negotiate individual funding levels for each government program, including 21st Century Community Learning Centers (21st CCLC). #### FY19 21st CCLC RFP Modification

A recent modification to the FY19 21st Century Community Learning Centers (21st CCLC) RFP allows nonprofit agencies, community/faith-based organizations, for-profit entities, and colleges and universities to apply an eight percent indirect cost rate for their services rather than the 3.15 percent previously stated.
