## Afterschool for Children and Teens

### Policy

#### Federal Budget Update

On February 12, 2018, the Trump administration released its full FY19 budget. The proposal eliminates or cuts funding to programs that are vital for children and families, including:

- Funding for 21st Century Community Learning Centers (CCLC), the only federally sponsored afterschool program, was proposed for elimination.
- Funding for the Child Care and Development Block Grant (CCDBG), which supports low-income working families with quality child care, was reduced by \$2.9 billion.
- Funding for Title IV Part A Student Support Academic Enrichment Grants, which provides all students with access to a well-rounded education, was proposed for elimination.
- Funding for the Youth Mentoring Initiative was reduced by \$22 million for an allocation of \$58 million.
- Funding for the Corporation for National and Community Service's AmeriCorps VISTA, a volunteer service program used by many afterschool programs, received a proposed funding level of \$5 million, which represents a \$92 million reduction.

#### Governor Rauner's FY19 Budget Address

Governor Rauner delivered his FY19 budget address on February 14, 2018. The proposed budget allocates \$12.5 million for Teen REACH. Although this is \$7 million less than what the General Assembly appropriated in July 2017, it is the first time Teen REACH has been included in the Governor's budget in his term. This inclusion will allow contracts to be obtained in a timely manner and for youth to receive the critical services that they need. Thanks to all the afterschool advocates and providers around the state for your tireless advocacy efforts.

Unfortunately, other programs that serve youth and families did not fare as well. The

proposed budget eliminates the State Board of Education's funding for After School Matters, the Healthy Communities Incentive Fund, and their afterschool programs line. In addition, Child Care Services is recommended for funding at \$380.7 million, representing \$96.1 million cut. Park district afterschool program funding remained level, but the Boys and Girls Scouts received a funding cut. To access the governor's budget proposal, click [here](#). ### **ISBE Board Meeting**

The Illinois State Board of Education (ISBE) met on February 14, 2018. The meeting packet can be found [here](#). Public comment centered on alternative school programs and their lost ability to count growth due to the evidence based funding language.

An update was provided on the Partnership for Educator Preparation (PEP) pilot. The PEP data will inform ISBE and state higher education institutions on licensure and the quality of the educator preparation process. In regards to ESSA, ISBE is in the process of identifying vendors for the IL-EMPOWER pilot. The information gathered will help to inform the statewide launch of the system in August 2018. ISBE has also provided guidance for meeting the ESSA site-based expenditure reporting requirement. That information can be found in the board packet. The next meeting will be held on **Wednesday, March 14, 2018** in Springfield.
