### Policy

#### FY19 STEM Funding

President Trump's FY19 Budget Proposal eliminates funding for many initiatives that support out-of-school time STEM work. The administration proposes that increasing the Education Innovation and Research program allocation and adding a competitive grant for STEM-focused career and technical education programs would meet their 2017 STEM and computer science education priorities. However, the congressional support required is not likely, and neither request details how STEM education funds will be spent. The Illinois Statewide Afterschool Quality Standards encompass seven Core Areas, which capture practices that research demonstrates lead to quality programs and positive outcomes for children and youth.

Mary's House, a licensed childcare provider in Centralia, Illinois, uses the Quality Standards booklet to help with the planning and implementation of their school-age program. As a result of attending a Quality Standards provider training, Mary's House has been more
