ESSA Title IV Funding

The FY18 omnibus spending plan includes \$1.1 billion in aid for Title IV Part A Student Support Academic Enrichment (SSAE) grants. Districts can use the monies to fund a broad range of priorities that fall under a well-rounded education, including safety, counseling, and science, technology, engineering, and mathematics (STEM).
