Federal Budget Update

On June 15th, the U.S. House Labor, Health and Human Services, Education Appropriations (LHHS) Subcommittee voted to approve their FY19 spending bill. It maintains funding for the 21st Century Community Learning Center (21st CCLC) afterschool and summer learning programs at the FY18 level of \$1.212 billion. The bill will be considered by the full Appropriations Committee before heading to the House floor. The Senate LHHS subcommittee is scheduled to markup their spending bill on June 26th, followed by the full Appropriations Committee on June 28th. 21st Century Information Collection Requirements

The U.S. Department of Education's request for comments regarding information collection requirements, specifically the 21st Century Community Learning Centers Annual Performance Report (21APR), were due on Monday, June 25th. In response to federal register Docket No.: ED-2018-ICCD-0047, the Afterschool Alliance and ACT Now emphasized the importance of data collection for 21APR and provided recommendations for aligning the Government Performance and Results Act standards to 21st CCLC objectives and Every Student Succeeds Act provisions.
