#### **Teen REACH Update**

DHS began distributing Teen REACH funding notices on October 28, 2016. Despite the stopgap deadline of December 31, 2016, DHS has indicated that they will provide full payment to programs through June 30, 2017. Teen REACH grant recipients must establish an external Illinois.gov account using the DoIT Identity Management system. ### **ESSA Round Three of Statewide Listening Tour**

Congress passed the <u>Every Student Succeeds Act</u> (ESSA) in December 2015, reauthorizing the nation's largest education law with many much needed updates and revisions. Included in ESSA is language that is favorable to afterschool programs. It is important that afterschool providers point this out to ISBE so that it is incorporated in Illinois' plan.

The second draft of the plan will be released in mid-November and will be posted at <a href="isbe.net/essa">isbe.net/essa</a>. Following the release, ISBE will be hosting its third round of listening tour meetings, which will provide participants an opportunity to engage in a group discussion regarding the ESSA State Plan and a chance to provide feedback. #### **Child and Adult Care Food Program**

The USDA's Food and Nutrition Service <u>Child and Adult Care Food Program (CACFP)</u>: <u>Meal Pattern Revisions Related to the Healthy, Hunger-Free Kids Act</u> amended the CACFP meal pattern regulations. The final rule requires that centers and day care homes, including afterschool programs and family child care homes, participating in CACFP serve more whole grains, serve a greater variety of vegetables and fruit, and

reduce the amount of added sugars and solid fats in meals. Centers have until October 1, 2017 to comply. For more information, click <u>here</u>.

#### Title IV, Part A Non-Regulatory Guidance

The U.S. Department of Education recently released its non-regulatory guidance on student support and academic enrichment (SSAE) grants, authorized under Title IV, Part A. The guidance document provides information on the activities that LEAs may conduct under the SSAE program and offers examples of practices that may be helpful to grantees. It requires LEAs receiving an SSAE program allocation of at least \$30,000 to use at least 20 percent of the SSAE program funds for activities that support student access to a well-rounded education. It also necessitates that these programs and activities be coordinated with other schools and community-based services. Allowable uses of these funds include programming and activities that improve instruction and student engagement in STEM subjects. Assuming that funding is appropriated, the SSAE program will be implemented in the 2017-2018 academic year. The Senate appropriations bill currently proposes funding the program at \$300 million, the House bill proposes \$1 billion, and ESSA authorizes spending at \$1.65 billion. # **Funding Opportunities**

#### **Afterschool Meals Grant**

No Kid Hungry Illinois is offering mini-grants up to \$2,500 that can be used by schools, child care centers, and eligible non-profit or for-profit organizations to help maximize their ability to serve full supper meals through the Child and Adult Care Food Program (CACFP) At-Risk After-School Meals Program. Grants may be used toward staffing, equipment, outreach materials, transportation, and other program costs. To apply for funding you will need to first create an account using the access code: ILCACFP2017. Applications must be submitted by Friday, November 18, 2016. The grant portal can be accessed here.

#### **School Breakfast Grant**

The No Kid Hungry Illinois Breakfast Grant provides schools with up to \$5,000 for the purchase of approved equipment, materials, and initiatives facilitating alternative breakfast models such as Breakfast in the Classroom, Grab N Go or Second Chance Breakfast. To apply for funding you will need to first create an account using the access code: ILBREAKFAST2017. Applications must be submitted by **Friday**, **November 18**, **2016**.
