### Policy Update

#### **Donald Trump Won. What's Next for Afterschool?**

In response to the upcoming change in leadership, the Afterschool Alliance has sent a memo to Trump's transition team calling for continued support of children and working parents through leveraging federal funds used by local school and community based-afterschool and summer learning programs. #### **Teen Teen REACH Update**

DHS began distributing Teen REACH funding notices on October 28, 2016. Despite the stopgap deadline of December 31, 2016, DHS has indicated that they will provide full payment to programs through June 30, 2017. Teen REACH grant recipients must establish an external Illinois.gov account using the DoIT Identity Management system. Steps for creating an account can be found [here](#).

#### **ESSA Round Three of Statewide Listening Tour**

Congress passed the [Every Student Succeeds Act](#) (ESSA) in December 2015, reauthorizing the nation's largest education law with many much needed updates and revisions. ISBE is working on its plan to implement this new law, which provides Illinois with many opportunities to tailor implementation to our needs. You can find ISBE's draft plan [here](#).

**There is a lot of language in ESSA that is very favorable to afterschool programs—even programs outside of 21st Century. It is important that afterschool providers point this out to ISBE so that it is included in Illinois' plan.**

### **21st CCLC RFP Recommendations**

The passing of the Every Student Succeeds ACT (ESSA) provides the Illinois State Board of Education (ISBE) an opportunity to revise its 21st Century Community Learning Centers (CCLC) process. Under the guidelines, ISBE must consult with stakeholders who have relevant and demonstrated expertise in 21st CCLC program and activities. In response, ACT Now and its partners have provided ISBE recommendations that would make the RFP process more transparent and supportive of out-of-school time.

We are encouraging 21st CCLC advocates to share these recommendations with their legislators and ISBE.
