ISBE Board Meeting

The Illinois State Board of Education met on December 13, 2017. The agenda and materials can be found here. At the meeting, the Board also discussed its FY19 budget and heard presentations about the state and economic factors that will affect their budget this year. Overall, ISBE does not expect growth for FY19 revenue, and the budget will look substantially different because of the new evidenced-based funding mechanism. The Board also specifically called out ACT Now's request to increase funding for afterschool. ISBE will present their budget at their January meeting. The Board discussed that ISBE representatives attended town halls recently to discuss ESSA and is expecting reports on College and Career Readiness and 3rd-8th grade accountability measures at the end of the month. In regards to the public comment at the November meeting about Special Education in CPS, ISBE will be exploring a public inquiry. For information about future board meetings, click here.
