Stopgap Funding Update

With only a few days to spare, Congress and President Trump agreed on a stopgap spending bill to avoid a government shutdown. Meanwhile, Senate appropriators continue to work on FY20 spending bills to fund the government for the rest of the fiscal year. This means Congress has not yet set 21st Century Community Learning Centers' funding levels for FY21. However, this is a forward funded program, so this year's funding level is secure.
