## Policy Updates

### Federal Updates

#### Afterschool & The Census

A new U.S. census will begin in 2020. The census is a count of people living in the U.S. that is conducted every 10 years. It is critical that the census is accurate, as the results of the census are used to determine how over \$900 billion of federal spending will be allocated for the subsequent 10 years. Millions of U.S. children and youth rely on this federal support to attend afterschool and summer learning programs. The [Afterschool Alliance](#) has created a [toolkit](#) to help afterschool programs, staff, and youth insure that every member of their community is counted.

### State Updates

#### Perkins CTE Listening Tour

The federal reauthorization of Perkins V was signed into law by the President on July 31, 2018. The purpose of this Act is to develop more fully the academic knowledge and technical and employability skills. Perkins V requires secondary, postsecondary and business/industry to work together to strengthen career and technical education for students.

Illinois will need to submit a Perkins V 4-year state plan in April 2020. Prior to the finalizing the state plan, the Illinois State Board of Education (ISBE) and the Illinois Community College Board (ICCB) will be holding regional events to share the state's draft Perkins V Plan.
